All transactions made with EMR SHIELDING SOLUTIONS are made within these terms:

Product specifications

EMR SHIELDING SOLUTIONS warrants that the goods will at the time of delivery correspond to the description given by EMR Shielding Solutions. It is the responsibility of the customer to check the suitability of goods for any particular purpose before ordering.

Payment

EMR SHIELDING SOLUTIONS normal terms of business are for all payments to be completed before the dispatch of goods. When payment is by cheque, dispatch of goods will occur when the cheque has been cleared. All final prices include goods and services tax (where applicable) unless otherwise stated. Delivery charges will be added to the final order cost based on postal information provided upon ordering. EMR SHIELDING SOLUTIONS at its absolute discretion may accept or reject any order for any reason whatsoever.

Delivery

Whilst every reasonable effort shall be made to keep to any delivery date, EMR SHIELDING SOLUTIONS shall not be liable for any losses, costs, damages or expenses incurred by the customer or any other person or company arising directly or indirectly out of any failure to meet any estimated delivery date.

Refund/ Returns Policy

If EMR SHIELDING SOLUTIONS are informed within 3 days of purchase that an item that has been purchased is faulty and the item is returned within 14 days of purchase a full refund or replacement item/s will be given. You are advised to package the product adequately as we cannot accept liability for any damage incurred during delivery back to EMR SHIELDING SOLUTIONS. Customer tailored products such as shielding material sold by the meter, and opened paint bins are not returnable. No product (such as unopened paint) can be refunded if it is not returned in good condition within 14 days from purchase. Before sending back product, the customer is required to contact EMR SHIELDING SOLUTIONS via email or telephone. EMR SHIELDING SOLUTIONS will then decide how to proceed and inform the customer accordingly. The costs of the return have to be borne by the customer. The customer shall report any short delivery to EMR SHIELDING SOLUTIONS in writing within 3 days of delivery (for instrument hire, see below). The missing item will be sent free of further charge to the customer. EMR SHIELDING SOLUTIONS will not be responsible for any business loss (including loss of profits, revenue, contracts, anticipated savings, data, goodwill or wasted expenditure) or any other indirect or consequential loss that is not reasonably foreseeable to both you and us when you commenced using the website or when goods were purchased and full payment received.

Shipping

The shipping weight of all goods is shown on the Pricelist. The cost of shipping will be added to the final invoice and at all times remains the customers' responsibility. The customer has the right to collect his goods by appointment for no cost. When ordering goods from EMR SHIELDING SOLUTIONS for delivery overseas you may be subject to import duties and taxes. Ownership and Risk

Product misuse and safety

Should any product malfunction as a result of abnormal environmental factors (including without prejudice to the generality of the foregoing, electromagnetic interference, extremes of humidity, vibration, electro-static damage, temperature or pressure or chemical corrosion) then all costs incurred by EMR SHIELDING SOLUTIONS in repairing such products and investigating the causes of the malfunction shall be payable to EMR SHIELDING SOLUTIONS. The customer is responsible for handling and processing EMR SHIELDING SOLUTIONS products in a safe manner. The customer is also responsible for the observation of all applicable safety procedures, especially for the prevention of electrical accidents. It is mandatory for the customer to follow the instructions on applicable "Handling and Processing" instruction sheets (available from EMR SHIELDING SOLUTIONS).

All EMR-Shielding paints (and other relevant shielding products) must be properly grounded in order not to present a potential safety hazard for occupants. The customer is responsible for the proper grounding of products. Grounding has to be designed and installed in such a manner that it cannot be removed or damaged and should be visually inspected regularly, to maintain grounding installation and repaired, if necessary. In Australia this must be carried out by a licensed electrician. The customer is responsible to follow all applicable laws and standards.

12 Months warranty is applicable for all EMR SHIELDING SOLUTIONS products. This warranty does not limit other warranties as prescribed by law. Instruments to hire

Terms and conditions for instrument hire contracts will be the same as for items purchased, with the following amendments:-

We require a deposit, the value of which will be listed on our current price list. This deposit will be returned, in full when the instruments are received back in complete working order. The customer shall report any damage to EMR SHIELDING SOLUTIONS by email within 24 hours of delivery of the instrument. If the customer damages the instruments through misuse, they are liable for repair costs. The risk in the goods shall pass from EMR SHIELDING SOLUTIONS to the customer upon delivery of such goods to the customer for the duration of the hire contract, and until delivery of the returned instruments to EMR SHIELDING SOLUTIONS.

Title and property in the goods, including full legal and beneficial ownership, will remain with EMR SHIELDING SOLUTIONS at all times. Non-return of the instruments under a hire contract will result in the payment of the full price of the instruments by the customer to EMR SHIELDING SOLUTIONS. Late return of the instruments will result in a daily late return payment being due to EMR SHIELDING SOLUTIONS by the customer under the terms of the hire letter accompanying the instrument on its dispatch to the customer.

Liability
